



## Annual Human Rights Competition 2024/2025

### Photography the Human Rights

#### Contest Rules

##### **Article 1:**

As part of its activities, the Association Regards d'Enfants organizes the competition:

##### **Photograph human rights!**

Create a photo album to show human rights by drawing on places, characters, values or your imagination. This album may be multi-page and may have a caption. It can tell a story or not, it can take the form of a photo novel or an artistic work...

##### **Article 2 :**

This contest is designed to enable young people to express their vision of human rights and the values promoted by the Council of Europe, by taking ownership of them and sharing them collectively. Teachers or educators supervising the work shall ensure that they respect the rules of objectivity, impartiality, probity and secularism.

##### **Article 3 :**

The contest is open to all young people up to 26 years old individually or in groups (Schools, specialized institutes, socio-cultural centers, extracurriculars...)

##### **Article 4 :**

Young people can let their imagination run free in the proposed achievements within the framework of compliance with the above rules.

The contribution may take the following forms:

- a printed document, necessarily accompanied by a presentation document written on the same type of medium;
- a document stored on a digital medium, necessarily accompanied by a presentation document written on the same type of medium
- an interactive digital presentation (slideshow, e-book, website, webdoc, etc.), including texts and/ or photos, necessarily accompanied by a written presentation document (all documents being stored on a digital medium)

##### **Article 5 :**

The creations must be sent to the Association via the Internet, social networks or by post. The shipment is under the responsibility and, where applicable, at the expense of the shipper.

The creations must include the following information:

- . Children's Looks 2024-2025 «Photography the Human Rights»
- . The name, first name, age, postal address, country, telephone number and email of the contact as well as the name of the school attended if school or group participation.
- . For institutions, the list of young participants

**Article 6 :**

Les Digital creations must be readable independently of any paid software except those in the office pack (Word, Excel, PowerPoint). If it is an audiovisual creation, the recording time will not exceed 3 minutes.

**Creations that do not comply with these conditions will not be accepted.**

Digital creations will be named as follows: If individual creation: Conc2025\_Name\_Firstname  
If it is a collective creation: ESTABLISHMENT Name\_Conc2025

**Article 7 :**

The information sheet should be sent to the association. This form must be completed on the computer in the language of the country and translated into French. This sheet is essential: no creation, even digital, will be considered by the jury without this sheet. **Article 8 :**

A jury chaired by Ambassador Pap N'Diaye, Permanent Representative of France to the Council of Europe, and composed of personalities committed to the defence of human rights will deliberate in order to select the winners.

The works will be evaluated according to the following criteria:

- **Respect of the contest theme**
- **Promotion of one or more human rights values**
- **creativity and originality of the work**
- **quality of presentation**

**The ability of students to take over their role as future human rights ambassadors (delivering a message, conveying an emotion) will also be taken into account.**

**Article 9 :**

Creations must be sent by **Friday, March 28, 2025** to:

**Association Regards d'Enfants, 58 avenue des Vosges, 67000 STRASBOURG –France**

The achievements posted or handed in after this date will not be considered. An acknowledgement by email will be sent by the Association Regards d'Enfants.

**Article 10 :**

Authors and their legal representatives assign all rights related to the Association Regards d'Enfants. The works may be published in any medium and form

**Article 11 :**

A graduation ceremony is held in Strasbourg, after which the winners and their supervisors are appointed **Ambassadors of Human Rights**. Travel and accommodation expenses are borne by the winners.

**Article 12 :**

By taking part in the graduation ceremony, participants authorize the Association Regards d'Enfants, 58 avenue des Vosges, 67000 Strasbourg -France to reproduce on any medium and by any process and to disseminate, without financial compensation, the (or) photography(s), the film and or recording (hereinafter the works) representing them, taken/made as part of the ceremony organized by the Association.

The above works will be used by the Association Regards d'Enfants to communicate about the activity of the Association. The authorization is exclusively for distribution by or under the direct control of the Association Regards d'Enfants, on paper (leaflet, information brochure, poster) or in digital form, via the Internet and in particular on the [www.regardsdenfants.org](http://www.regardsdenfants.org) website, Facebook: <https://fr-fr.facebook.com/Regards-denfants-Views-of-children-108693502503620/>, and media.
